Summary Statement

The Precinct 4 polling place has been at the Wells Fargo Bank community room. The bank will close in September 2020, therefore, not being available for election purposes. The proposed location to move to, the Post Community Center, would be shared with the Precinct 2 polling place. The center is just one block and across the street from the bank. It is also, surrounded by the Precinct 4 territory. Both precincts will have separate ballots and poll workers.

On the 22nd day of June, 2020, the Garza County Commissioners' Court approves the combining of election polling places for the November 3, 2020 General Election. The Court hereby combines two (2) voting precincts at one (1) polling location as follows: #2 and #4 at the Post Community Center.

Due to the closing of the business at the Precinct 4 location, the Commissioners' Court of Garza County, Texas determines that it would be more convenient to the voters to conduct the November 3, 2020 General Election by combining election polling places as recited above.


Making this change will be more convenient to the registered voters and will not change county election precinct boundaries.


