Permanently relocate the Precinct 6 polling place to the Justiceburg Community Church.

Actions:

Vote to approve the relocation of the polling place.

County Policy:

Need commissioners' court approval.

Summary Statement

The Precinct 6 polling place at the Lake Alan Henry Firehouse will be partially inaccessible for the November 3, 2020 General Election. A bridge between the firehouse and Highway 84 may undergo construction. Also, the usual poll workers have complained about fumes at the firehouse making them sick.

The proposed location is the Justiceburg Community Church at 2511 U.S. Highway 84 just south of the turnoff to Lake Alan Henry. It is 8 miles west of the current polling place. The proposed area to use for voting is a new part of the church which is compliant with the American with Disabilities Act and is easy to locate.


Making this change will be more convenient to the registered voters and will not change county election precinct boundaries.


