Garza County will hold a public hearing at the Garza County Courthouse in the courtroom on the 2<sup>nd</sup> floor on Tuesday, August 5th, 2014 at 5:05 pm, in regard to the Texas Community Development Block Grant Program project that has recently been completed in Garza County.

This public hearing is being held to review the outcome of the Community Development Block Grant Disaster Relief water improvements in Garza County. The grant was used to make water improvements in the following locations:

Contractor has rehabilitated an existing well field to expand its production to provide the White River MWD with an additional resource of water. Contractor shall rehabilitate two (2) wells, , two (2) well pumps, , piping, and all associated appurtenances. Construction shall take place at well #1, located at approximately two and half (2.5) miles east of the intersection of State Highway 207 and CR 162 on CR 162, at well #2, located at approximately two and seven tenths (2.7) miles east of the intersection of State Highway 207 and CR 162 on CR 162.

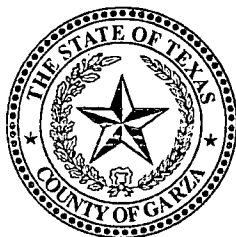
