





A regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, June 4, 2012 at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, TX with the following members present: Lee Norman, Judge; Commissioners: Pct. 1-Gary McDaniel, Pct. 2-Charles Morris, Pct. 3-Ted Brannon and Pct. 4-Jerry Benham.

County officials present: Mike Munk, Attorney.

Also present: Billie Williams, Administrative Assistant; and Rebecca Quintana, Assistant Deputy Clerk.

Judge Norman called the meeting to order at 9:05 a.m.

- Order 1: Minutes from the May 24, 2012 regular meeting were approved as presented with a motion by Commissioner Morris and seconded by Commissioner Benham. With a majority of the court members voting aye, the motion carried and so ordered.
- Order 2: The following items of information were brought before the Court as a written report or for discussion:
None were submitted.
- Order 3: Came on to be considered were the precinct and countywide accounts payable for May 25, 2012 through June 4, 2012.
Motion was made by Commissioner Benham and seconded by Commissioner Morris that all such accounts presented in the fund requirement print-out are ordered paid and presented to the Treasurer for payment.
With a majority of the court members voting aye, the motion carried and so ordered. (Printout is attached.)
- Order 4: Came on for consideration was an Order Prohibiting Certain Fireworks in Unincorporated areas of Garza County.
A motion was made by Commissioner Brannon and seconded by Commissioner Morris to impose the Order for Prohibiting Certain Fireworks beginning June 25, 2012 and ending July 5, 2012. With a majority of the court members voting aye, the motion carried and so ordered. (Order is attached.)
- Order 5: Came on for consideration were line item transfers and budget amendment requests.
None were submitted.

Order 6: Heating and Cooling Project

Order 7: Public Comment
