County official present was Jim Plummer, Clerk.

Also present: Jana Williams, attorney with Allison, Bass and Associates; and citizens' advisory committee members Darren Weaver, Lupe Cisneros and Tom Middleton.

Judge Norman called the meeting to order at 10:08 A.M.

Order 1: Came on before the court was a public hearing for the redistricting of county political precinct boundaries as a result of the 2010 U.S. Census. Jana Williams, attorney with Allison, Bass and Associates explained the laws pertaining to redistricting. Also, that the county population is down 50 people since the 2000 U.S. Census, not including the prison population. Two plans were considered.

Clerk Plummer, speaking on behalf of Voter Registrar Judy Bush, informed the court that she prefers Plan 10.


The meeting recessed at 10:27 a.m.

The meeting resumed at 10:31 a.m.



The meeting adjourned at 10:36 p.m.


