

Judge Norman called the meeting to order at 2:03 p.m.

Public Hearing, Budget 2012-2013

Came on before the court was the second of two public hearings concerning the proposed 2012-2013 budget.

Judge Norman said the meeting is required if the county proposes a tax increase.

Proposed rate: .355 rate (down from .37809)

Revenue: \$2,938,150

Revenue increase: \$221,511

Valuations: \$969,698,155

Valuations increase: \$124,384,419

Judge Norman pointed out changes in budget. (See attachment.)

Deputy County Clerk Terri Laurence presented a special request for a salary increase above the across the board 4% to match the clerk's chief deputy salary. (Request is attached.) Clerk Plummer requested time to review his budget and to did not recommend any changes to the clerk's budget at this time.


There was not any public comment.

The meeting adjourned at 2:24 p.m.


Adopting the 2012-2013 budget and setting the tax rate is set for Friday, September 21, 2012 at 9:00 a.m.
