

A special meeting of the Commissioners' Court of Garza County, Texas was held on Tuesday, July 30, 2013 at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, TX with the following members present: Lee Norman, Judge; Commissioners – Pct. 1-Gary McDaniel, Pct. 2-Charles Morris, Pct. 3-Ted Brannon and Pct. 4-Jerry Benham.

County officials present: Preston Poole, Attorney; Ruth Ann Young, Treasurer; Terry Morgan, Sheriff; Gordon Terry, Justice of the Peace Pct 1; and Angela Massey, Justice of the Peace Pct 2.

Also present: Terri Laurence, Deputy County Clerk; Brandt Taylor, Chief Probation Officer; and Dena Watson, City of Post, Manager.

Effective tax rate: .375

Rollback rate: .40495 will generate \$3,716,828.25 from ad valorem taxes.
