

A regular meeting of the Commissioners' Court of Garza County, Texas was held on Wednesday, August 14, 2013 at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, TX with the following members present: Lee Norman, Judge; Commissioners: Pct. 1-Gary McDaniel; Pct. 2-Charles Morris, Pct. 3-Ted Brannon and Pct. 4-Jerry Benham.

County officials present: Jim Plummer, Clerk; Ruth Ann Young, Treasurer; Nancy Wallace, Tax Collector/Assessor; and Terry Morgan, Sheriff.

Also present: Meg Nelson, Administrative Assistant; and Brandt Taylor.

Judge Norman called the meeting to order at 9:05 a.m.

Order 1: 2014 Budget (session)

Sheriff Morgan informed the court that the City of Post met last night and agreed to split the costs of Patrol and Dispatch for a total of \$455,021.

The court started on Page 4, Reimbursements/Supplements.

A motion was made by Commissioner McDaniel and seconded by Commissioner Morris to NOT allow a specific salary increase for the Deputy County Clerk as requested by the District and County Clerk. With a majority of the court members voting aye, the motion carried and so ordered. (Judge Norman voted to break the tie in favor of the motion.)

The meeting recessed at 10:04 a.m.

The meeting resumed at 10:21 a.m.

The court continued on Page 39, Probation.

A tax rate of .399 will net \$78,017 in the general fund.

Order 2: A motion to approve the proposed total ad valorem tax rate of \$0.399 per \$100.00 property valuation was made by Commissioner McDaniel and seconded by Commissioner Benham. The rate does not exceed the roll back rate of .407.

RECORD VOTE

With the vote being called for and all five court members voting aye, the motion carried and so ordered.

Order 3: Schedule Public Hearing

A motion was made by Commissioner Morris and seconded by Commissioner Brannon to approve the following schedule for the budget process:

9/3/13, 6:00 p.m.: First public hearing at courthouse.

9/9/13, 10:30 a.m.: Second public hearing at courthouse.

9/23/13, 10:30 a.m.: Adopt the budget and set the tax rate.

With a majority of the court members voting aye, the motion carried and so ordered.

The meeting adjourned at 10:48 a.m.

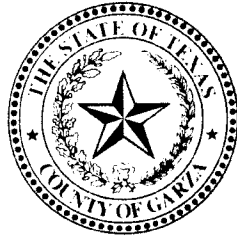
