

A special meeting of the Commissioners' Court of Garza County, Texas was held on Tuesday, September 3, 2013 at 5:30 p.m. at the Commissioners' Courtroom, 300 W. Main St., Post, TX with the following members present: Lee Norman, Judge; Commissioners – Pct. 1-Gary McDaniel, Pct. 2-Charles Morris, Pct. 3-Ted Brannon and Pct. 4-Jerry Benham.

County officials present: Jim Plummer, District and County Clerk; Ruth Ann Young, Treasurer; Nancy Wallace, Tax Collector/Assessor; and Terry Morgan, Sheriff.

Also present was Meg Nelson, Administrative Assistant.


Judge Norman called the meeting to order at 5:33 p.m.

Order 1: Came on for discussion was the heating and cooling project. Judge Norman informed the court that the next step could be the third floor for a cost of \$39,000 to \$40,000, an estimate from Post Heating and Air. The company believes the 2nd and 3rd floors will cost \$180,000 total. Motion was made by Commissioner Morris and seconded by Commissioner Benham to approve the \$40,000 for the heating and cooling of the second phase which is the third floor. With a majority of the court members voting aye, the motion carried and so ordered.


The meeting adjourned at 5:40 p.m.

GARY MCDANIEL, COMMISSIONER PCT. 1





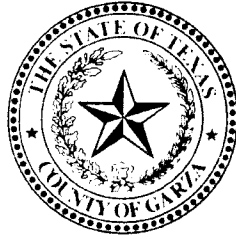
