Public Hearing, Budget 2013-2014


Came on before the court was the first of two public hearings concerning the proposed budget for the 2013-2014 fiscal year.

Judge Norman briefly explained basic budget and revenue increases and increase in expenses. He also announced that the effective tax rate is .37708 and that property valuations are down \$51,813,522 at \$917,785,139. He added that the City of Post is increasing its law enforcement budget by over \$100,000.


There was not any public comment.

The meeting adjourned at 6:10 p.m.


The second public budget hearing is set for Monday, September 9, 2013 at 10:30 p.m. following the regular meeting at 9:00 a.m.

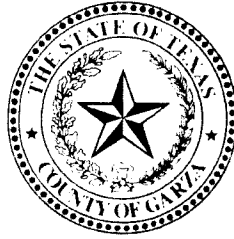
