

A special meeting of the Commissioners' Court of Garza County, Texas was held on Monday, September 9, 2013 at 10:30 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, TX with the following members present: Lee Norman, Judge; Commissioners: Pct. 1-Gary McDaniel, Pct. 2-Charles Morris, Pct. 3-Ted Brannon and Pct. 4-Jerry Benham.

County officials present: Jim Plummer, District and County Clerk; Ruth Ann Young, Treasurer; Nancy Wallace, Tax Collector/Assessor; Preston Poole, Attorney; and Terry Morgan, Sheriff.

Also present was Meg Nelson, Administrative Assistant; and Wayne Hodgin, the Post Dispatch.

Judge Norman called the meeting to order at 10:30 a.m.

## 2<sup>nd</sup> Public Hearing, Budget 2013-2014

Came on before the court was the second of two public hearings concerning the proposed budget for the 2013-2014 fiscal year.

Tax Collector Nancy Wallace explained legislative changes that affect her office including property tax pay-out agreements and picture IDs for title changes. Also, registration of agriculture vehicles will require an Ag number issued by the state comptroller's office. She added that a property owner may pay out a tax levy every other year and can pay off the bill over 12 months.

Judge Norman reviewed the tax rate, revenue, valuations and budget changes from the 1<sup>st</sup> public hearing. Total valuations are down \$51,813,522. Proposed tax rate is .399. (Figures are attached.)

Wayne Hodgin, Post Dispatch, asked a few questions.


Schedule and Announce the Meeting to adopt the 2014 tax rate.


The meeting adjourned at 10:52 a.m.




