The Commissioners Court of Garza County, Texas, pursuant to Chapter 222.1071 of the Texas Transportation Code, hereby gives notice of a Public Hearing, to be held on the 23rd day of December, 2013, at 9:00 o'clock a.m., at the Garza County Courthouse, to take up for consideration the following topics:

1. Open a Public Hearing to present information and receive public comments on the following topics:
 - a. Whether or not to create one or more County Energy Transportation Reinvestment Zone (CETRZ), as authorized by law, to promote one or more infrastructure projects to be located within the County to be funded by the CERTZ. Additional information on this topic may be found on the Texas Department of Transportation website: <http://www.roadstexasenergy.com> under the "Legislation" tab.
 - b. The potential boundaries and requirements of a County Energy Transportation Reinvestment Zone (CETRZ), as authorized §222.1071 of the Texas Transportation Code.
2. The Commissioners Court may, 30 days after closing the Public Hearing, take appropriate action on the matter, as the Commissioners Court may in its discretion determine to be in the best interest of the County.




The court received questions from the attendees.

No action taken.



The meeting adjourned at 9:20 a.m.



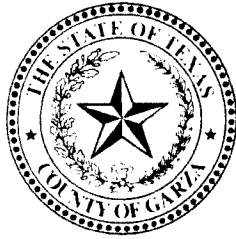
