A special meeting of the Commissioners' Court of Garza County, Texas was held on Wednesday, August 27, 2014 at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, TX with the following members present: Lee Norman, Judge; Commissioners – Pct. 1-Gary McDaniel, Pct. 2-Charles Morris, and Pct. 4-Jerry Benham. Pct. 3 Commissioner Ted Brannon was absent. County officials present: Jim Plummer, District and County Clerk; Ruth Ann Young, Treasurer; Nancy Wallace, Tax Collector/Assessor; and Ted Weems, Attorney.

Judge Norman called the meeting to order at 9:07 a.m.

Public Hearing, Budget 2014-2015

Came on before the court was the first of two public hearings concerning the proposed budget for the 2014-2015 fiscal year.

No one from the public was present.

Judge Norman reported on the juvenile board meeting and said they approved the board's budget. Probation Officer, Brandt Taylor requested the retention of Fund 14 money in the juvenile probation budget that is unspent at the end of the year. Attorney Weems said that he and Treasurer Young are not comfortable with that request and recommends to the court that the request be denied.

Treasurer Young explained that after expenses, there is \$18,064.63 in excess funds of the total county budget.

The court discussed the replacement of the courtroom seating.


Judge Norman briefly explained that the current tax rate is .399, the effective rate is .389626 and the proposed tax rate is .419 which is below the rollback rate.

The increases in expenditures are mostly due to raises, health insurance and law enforcement which are shared with the City of Post.

The meeting adjourned at 9:20 a.m.

The second public budget hearing is set for Thursday, September 4, 2014 at 6:00 p.m. following a special meeting at 5:30 p.m.






GARY MCDANIEL, COMMISSIONER PCT. 1
