Courtney Paz explained the grant proposal is for a \$113,000 matching grant.


Victor Ashley explained that the funds will be used to develop more water wells. He also mentioned that Shane Jones is the new district manager.

No action taken.


The meeting adjourned at 5:18 p.m.




