A regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, June 8, 2015 at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Commissioners – Pct. 1-Gary McDaniel, Pct. 2-Charles Morris, Pct. 3-Ted Brannon and Pct. 4-Jerry Benham.

County officials present: Jim Plummer, Clerk; Ted Weems, Attorney; Terry Morgan, Sheriff; Nancy Wallace, Tax Collector/Assessor; and LuAnne Terry, Treasurer.

Also present: Meg Nelson, Administrative Assistant; and Kent Mahoney, Post Dispatch.

Judge Norman called the meeting to order at 9:00 a.m.

Order 1: Minutes from the May 27, 2015 regular meeting were approved as presented with a motion by Commissioner Morris and seconded by Commissioner Benham. With a majority of the court members voting aye, the motion carried and so ordered.

Order 2: Reports from county offices - The following items of information were brought before the Court as a written and/or a verbal report:

- a. Treasurer
- b. Budget Usage Analysis
- c. Justice of the Peace, Pct. 1
- d. Guardianship
- e. County Court Appointed Civil Attorney
- f. District Court Appointed Civil Attorney
- g. Registrar of Death
- h. Senior Transportation
- i. Garza County Combination Tax and Revenue Certificates of Obligation, Series 2008 Bond, Reserve and Construction Funds
- j. Garza County Public Facility Corporation Taxable Project Revenue Refunding Bonds, Series 2012 Bond, Reserve and Project Funds; Rental, Operating, Surplus, Cost of Issuance, Escrow Accounts and Juvenile Facility Surplus Account.

Motion was made by Commissioner Brannon and seconded by Commissioner McDaniel to accept the reports as presented. With a majority of the court members voting aye, the motion carried and so ordered. (Written reports are attached.)

Order 3: Came on for consideration was the precinct and countywide accounts payable for May 28, 2015 through June 8, 2015.

Motion was made by Commissioner McDaniel and seconded by Commissioner Benham that all accounts presented in the fund

requirement print-out is ordered paid and presented to the Treasurer for payment. With a majority of the court members voting aye, the motion carried and so ordered. (Printout is attached.)

Order 4: Came on for consideration was the regulation of restricted fireworks. No action taken.

Order 5: Came on for consideration was revisions to the (personnel) policy manual.  
Motion was made by Commissioner Brannon and seconded by Commissioner Morris to approve the measurement period look back policy to be added to the policy manual and approve the clarification on the holiday pay schedule for regular part time employees. (Information is attached.)

Order 6: Came on for consideration was applications for public assistance.  
a. Attorney Weems informed the court that the applicant does qualify for assistance.  
Motion was made by Commissioner McDaniel and seconded by Commissioner Brannon to approve the application from A.V.: \$175 rent, \$1.26 water totaling \$176.26.  
With a majority of the court members voting aye, the motion carried and so ordered. (Application is attached.)  
b. Attorney Weems informed the court that the applicant does not qualify for assistance.  
Motion was made by Commissioner Benham and seconded by Commissioner Morris to DENY the application from J.V. With a majority of the court members voting aye, the motion carried and so ordered. (Application is attached.)

Order 7: Came on for consideration were line item transfers and budget amendment requests.

Two (2) line item transfers were submitted.

a. A motion was made by Commissioner McDaniel and seconded by Commissioner Brannon to approve the line item transfer presented for the Judge's office for \$3500.

With a majority of the court members voting aye, the motion carried and so ordered.

b. A motion was made by Commissioner McDaniel and seconded by Commissioner Brannon to approve the line item transfer presented for the R&B 2 office for \$432.99.

With a majority of the court members voting aye, the motion carried and so ordered.

Order 12: Public Comment

Kent Mahoney, Post Dispatch, thanked the court for its support for keeping public notices in local publications by opposing proposed, and unsuccessful, legislation of centralizing the process on the internet. Judge Norman explained that there were 6000 plus bills filed this legislative session.

*The next regular meeting is set for June 22, 2015.*





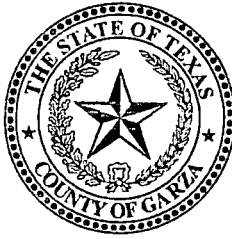
