A regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, January 11, 2016 at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Commissioners - Pct. 1-Gary McDaniel; Pct. 2-Charles Morris, Pct. 3-Ted Brannon and Pct. 4-Jerry Benham.

County officials present: Ted Weems, Attorney; Terry Morgan, Sheriff; Luanne Terry, Treasurer; and Nancy Wallace, Tax Assessor/Collector.

Also present: Meg Nelson, Administrative Assistant; Ginger Butler, Deputy Clerk; and Kent Mahoney, Post Dispatch.

Judge Norman called the meeting to order at 9:00 a.m.

- Order 1: Minutes from the December 28, 2015, regular meeting were approved as presented with a motion by Commissioner Brannon and seconded by Commissioner McDaniel. With a majority of the court members voting aye, the motion carried and so ordered.
- Order 2: Reports from county offices - The following items of information were brought before the Court as a written and/or a verbal report:
- a. Sheriff Morgan: Thanked those who helped after the awnings collapsed due to the snow. The county now has its fourth DPS trooper. He submitted the jail billing report (attached).
 - b. Tax Collector/Assessor Wallace: submitted a continuing education transcript for the year 2015. Kathy Nelson was introduced as the new employee in the tax office.
 - c. Jim Plummer (by Judge Norman): announced that a public meeting concerning the Consolidated Polling Place for the March 1, 2016 joint Primary Election is set for 5:30 pm on January 21, 2016 at the courtroom.
 - d. Tax Collector/Assessor
 - e. Clerk
 - f. Justice of the Peace, 1
 - g. Justice of the Peace, 2
 - h. County Court Appointed Civil Attorney - OCA
 - i. District Court Appointed Civil Attorney - OCA
 - j. Registrar of Death - SOS/TEAM
 - k. Guardianship & Mental Cases- DPS
 - l. AgriLife Extension - McDonald
 - m. Senior Van
- Motion was made by Commissioner Benham and seconded by Commissioner Brannon to accept the reports as presented. With a majority of the court members voting aye, the motion carried and so ordered.

- Order 3: Came on for consideration was the precinct and countywide accounts payable for December 29, 2015 through January 11, 2016. Motion was made by Commissioner McDaniel and seconded by Commissioner Morris that all accounts presented in the fund requirement print-out is ordered paid and presented to the Treasurer for payment. With a majority of the court members voting aye, the motion carried and so ordered. (Printout is attached.)
- Order 4: Came on for consideration was the use of county equipment during emergencies. Attorney Weems explained that the use of county equipment during an emergency is legal under the authority of the county judge or the emergency management coordinator. A non-county employee may not be covered under the county's insurance. Sheriff Morgan, discussed that about 15 people were stranded during the recent snow storm. No action taken.
- Order 5: Came on for consideration were line item transfers and budget amendment requests. None submitted.
- Order 6: Public Comment None presented.

The meeting adjourned at 9:16 a.m.
