

A special meeting of the Commissioners' Court of Garza County, Texas was held on Thursday, September 29, 2016 at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Commissioners, Pct. 1-Gary McDaniel, Pct. 2-Charles Morris, Pct. 3-Ted Brannon and Pct. 4-Jerry Benham.

County officials present: Jim Plummer, District and County Clerk; Ted Weems, Attorney; LuAnne Terry, Treasurer; and Terry Morgan, Sheriff.

Also present: Meg Nelson, Administrative Assistant; and Julia Childs, Post Dispatch.

Judge Norman called the meeting to order at 9:00 a.m.

Order 1: Minutes from the September 22, 2016, regular meeting were approved as presented with a motion by Commissioner Brannon and seconded by Commissioner Benham. With a majority of the court members voting aye, the motion carried and so ordered.

Order 2: Reports from county offices - The following items of information were brought before the Court as a written and/or a verbal report:

- a. Sheriff Morgan: Jail is full. Two new contracts will be on next meeting's agenda.
- b. Judge Norman: Discussed the roofing of the county barn and what materials to use to replace the surface of the awning. Options will be presented to the court later.

Motion was made by Commissioner Morris and seconded by Commissioner Benham to accept the reports as presented. With a majority of the court members voting aye, the motion carried and so ordered.

Order 3: Came on for consideration was the precinct and countywide accounts payable for September 23, 2016 through September 29, 2016. Motion was made by Commissioner Brannon and seconded by Commissioner Morris that all accounts presented in the fund requirement print-out is ordered paid and presented to the Treasurer for payment. With a majority of the court members voting aye, the motion carried and so ordered. (Printout is attached.)

Order 4: Came on for consideration was the fiscal year 2017 indigent defense contract for district court. Judge Norman informed the court that the 2017 cost is \$17,955. Attorney Weems explained that our percentage between the four counties in the district is up and added that the contract is in order. Motion was made by Commissioner McDaniel and seconded by Commissioner Benham to approve the contract with Attorney Arthur

Aguilar. With a majority of the court members voting aye, the motion carried and so ordered. (The contract is attached.)

Order 5: Came on for consideration was line item transfers and budget amendment requests.
One (1) budget amendment is submitted.
a. A motion was made by Commissioner McDaniel and seconded by Commissioner Morris to approve the budget amendment presented for the Estray account of the Sheriff's office for \$1670.
With a majority of the court members voting aye, the motion carried and so ordered.




