A regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, May 22, 2017 at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Commissioners, Pct 1-Jeff Williams, Pct. 2-Charles Morris, Pct. 3-Ted Brannon and Pct. 4-Jerry Benham. Not present was Judge Lee Norman.

County officials present: Jim Plummer, District and County Clerk; Ted Weems, Attorney; and LuAnne Terry, Treasurer.

Also present: Meg Nelson, Administrative Assistant; Tom Payton; and Julia Childs, Post Dispatch.

Judge Pro-tem Charles Morris called the meeting to order at 9:00 a.m.

- Order 1: Minutes from the May 8, 2017 regular meeting were approved as presented with a motion by Commissioner Brenham and seconded by Commissioner Brannon. With a majority of the court members voting aye, the motion carried and so ordered.
