

A regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, May 23, 2022 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Judge Norman called the regular meeting to order at 9:02 a.m.

Order 1: Prayer

Order 2: Pledge to Flags

Order 3: Public Comment None presented.

Order 4: Minutes from the May 16, 2022 regular meeting were approved as presented with a motion by Commissioner Benham and seconded by Commissioner Brannon. With a majority of the court members voting aye, the motion carried and so ordered.

Order 5: Came on for consideration was accounts payable from May 9, 2022 through May 23, 2022. Motion was made by Commissioner Morris and seconded by Commissioner Benham that all accounts presented in the fund requirement print-out is ordered paid and presented to the Treasurer for payment. Order 6: Reports from county offices - The following items of information were brought before the Court as a written and/or a verbal report:

Sheriff Morgan: Jail inmate count; Total 86, 35 are county inmates and 51 out of county.

Michael Isbell, Emergency Management Coordinator: Had a couple of fires. Lake Allen Henry Fire Department is having a fundraiser June 11, 2022 at the fire station in Justiceburg. Working on seizure paperwork for trailer and Mitigation grant for tank and pump for the subdivisions on south side of lake.

Danya Peterson, AgriLife Extension Agent: Reported five of her seniors have graduated and five more will graduate next week. GCJLA Brisket Fundraiser will be June 11, 2022. See attachment.

Judge Norman: Received notice from TAC stating Commissioners Court may adopt an order regulating certain fireworks in unincorporated areas of the county under drought conditions. Order must be adopted before June 15, 2022. Will be put on next agenda. Cybersecurity training needs to be completed. Every county employee with access to computers must be certified.
