



A Regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, July 10, 2023 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Commissioners, Pct. 1-Jeff Williams; Pct. 2-Kim Wilks; Pct. 3-Ted Brannon and Pct. 4-Giles W. Dalby.

Order 6: Reports from county offices-The following items of information were brought before the Court as a written and/or verbal report:

Sheriff Morgan: Jail Inmate count 84, 32 are county inmates and 52 out of county. June 2023 Calls for Service Reports. See attachment.

David Graves, Constable: Brent Meyers has been hired for the Deputy Constable for Pct. 1 beginning Sunday, July 16, 2023.

Michael Isbell, Emergency Management Coordinator: Have worksheets ready to send into FEMA. This is due to the damages of the recent flooding. Needing worksheets for costs of repairs, etc. from Commissioners on repairs of the roads.

Zane Reiter, Family Health Community Agent: Gave reports on numerous activities. See attachment.

Kylene Wheeler, Elections Administrator: Having Election Law changes.

Judge Norman: Went to a community meeting at the prison last week. Have over 800 prisoners at this time. Have all employees they need to fulfil the 1024 bed contract. Working on open house for the County for September 29th, 2023.


