

ORDER OF SPECIAL ELECTION (ORDEN DE ELECCION ESPECIAL)
November 7, 2023 (07 de noviembre de 2023)

An Election is hereby ordered to be held on November 7, 2023, in Garza County, Texas for the purpose of voting in a Special Election to adopt or reject the proposed Constitutional Amendments as submitted by the 88th Legislature (see Exhibit A), Regular Session and a Second Special Session of the State of Texas.




