



A Public Hearing of the Commissioners' Court of Garza County, Texas was held on Monday, March 11, 2024 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Order 1: Receive comments and input regarding the closing, abandonment and vacating of certain public roads. Mr. Weems explained that the Public Transportation Code gives Commissioners Court of each County the right to close, abandon and vacate roads no longer used for public purpose. Mr. Wheeler, a Southland Texas resident submitted a request to close certain streets in Southland Texas. XCEL Energy said they would need an easement to be developed. Mr. Weems said that would be between them and the landowner. Jamie Valdez ask if this would affect his property. Mr. Weems explained that it will not. Mr. Wheeler has paid expenses for the survey and for all notices sent out. If approved by the Commissioners Court, Mr. Wheeler will pay all recording fees.
