

A Regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, March 26, 2024 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. - Order 9: Consider to approve Grant Agreements for the Rural Law Enforcement Salary Assistance Program. A motion was made by Commissioner Brannon and seconded by Commissioner Williams to approve the Grant Agreements in the amount of \$250,000.00 for the Garza County Sheriff's Department and \$100,000.00 for Garza County Attorney's Office. SB 22 established a grant program that will provide financial assistance to sheriff's departments, constable's offices and district & county attorney's offices.  New line item for Garza County Sheriff to receive money for SB 22 Grant Fund to increase law enforcement salaries and buy vehicles and safety equipment in the amount of \$250,000.00.

 New line item for Garza County Attorney's Office to receive money for SB 22 Grant Fund to help with added positions in the office in the amount of \$100,000.00.

 A motion was made by Commissioner Wilks and seconded by

Commissioner Dalby to accept the budget amendments. With a majority of the court members voting aye, the motion carried and so ordered.
