

A Regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, May 13, 2024 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Commissioners, Pct. 1-Jeff Williams; Pct. 2-Kim Wilks; Pct. 3-Ted Brannon and Pct. 4-Giles W. Dalby. Section 74.602 of the Texas Property Code authorizes the Texas Comptroller of Public Accounts to allocate a portion of the unclaimed capital credits received from electric cooperatives back to counties in cooperatives' service areas. A motion was made by Commissioner Wilks and seconded by Commissioner Williams to approve the Unclaimed Property: Capital Credits for Counties. With a majority of the court members voting aye, the motion carried and so ordered.
- Order 11: Consider to approve Lease Agreements with American National Leasing Company for Constable, EMC and Sheriff Trucks. A motion was made by Commissioner Dalby and seconded by Commissioner Williams to approve the Lease Agreements. With a majority of the court members voting aye, the motion carried and so ordered.
