

A Regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, December 23, 2024 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Pct. 1-Jeff Williams; Pct. 2-Kim Wilks; Pct. 3-Ted Brannon and Pct. 4-Giles W. Dalby.

A motion was made by Commissioner Dalby and seconded by Commissioner Williams to take sealed bids instead of RFP. Sheriff Morgan informed the court there was funds received from Commissary from the Dalby Unit which could be used for the camera system. With a majority of the court members voting aye, the motion carried and so ordered.
