
a) Budget Impact Statement

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.


The following compares the taxes imposed on the average residence homestead by Garza County last year to the taxes proposed to be imposed on the average residence homestead by Garza County this year.
