

A Special meeting of the Commissioners' Court of Garza County, Texas was held on Monday, September 22, 2025 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Pct. 1-Jeff Williams; Pct. 2-Kim Wilks; Pct. 3-Byron Lane Jones and not present, Pct. 4-Giles W. Dalby. County officials present: Terri Laurence, District & County Clerk; Michael Isbell, Sheriff; Annhya Velez, County Attorney and LuAnne Terry, Treasurer. Also present: Carol Williams, Administrative Assistant; Bruce Boren, Constable Pct. 2; Kylene Wheeler, Elections Administrator; Shawna Jameson, Texas Division of Emergency Management and Anna Gibson, Post Dispatch.

Judge Norman called the Special Meeting to order at 9:00 a.m.

Order 3: Public Comment

Judge Norman introduced Shawna Jameson with the Texas Division of Emergency Management from Dickens, Texas. Her assigned county is Dickens but she is also in charge of seven eastern SPAG counties which include Garza.

Order 4: Minutes from the September 8, 2025 regular meeting were approved as presented with a motion by Commissioner Williams and seconded by Commissioner Wilks. With a majority of the court members voting aye, the motion carried and so ordered.

Order 5: Came on for consideration was accounts payable from September 8, 2025 through September 22, 2025. Motion was made by Commissioner Wilks and seconded by Commissioner Jones that all accounts presented in the fund requirement printout is ordered paid and presented to the Treasurer for payment. Discuss, consider and take action regarding the approval of the Order 7: sale of the Dalby Correctional Facility by the Garza County Public Facility Corporation to the TDCJ for \$110,000,000.00 and authorize the President or Vice President of the Garza County Public Facilities Corporation to execute all necessary documentation and take all necessary action related to the sale of the Dalby Correction Facility to TDCJ but not limited to the contract of sale deeds, assignment of leases and personal property, closing statements, payment of closing costs and disbursement of funds for the payment of liens and other obligations. A motion was made by Commissioner Wilks and seconded by Commissioner Williams to approve the sale of the Dalby Correctional Facility by the Garza County Public Facilities Corporation to the Texas Department of Criminal Justice. With a majority of the court members voting aye, the motion carried and so ordered. See attachment.

  of the court members voting aye, the motion carried and so
