

A Regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, October 27, 2025 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Pct. 1-Jeff Williams; Pct. 2-Kim Wilks; Pct. 3-Byron Lane Jones and Pct. 4-Giles W. Dalby. Reports from county offices-The following items of information were brought before the Court as a written and/or verbal Report:

Sheriff Isbell: Jail Inmate Count; 78, 23 are county inmates and 55 out of county. Coryell County is the jail's largest client.

Commissioner Pct. 1: Hired Paula Jackson for the Assistant Position at the Garza County Museum. Met with citizens in Southland regarding the fire they had recently. Set a meeting with the City of Post about getting water to Southland for these types of circumstances.

Commissioner Pct. 4: Asking directive from the court to move the three vans and one bus from the prison.

Commissioner Pct. 2: Have spoken with TXDOT concerning Ave F and 380 and have received no response back. They are currently working on Hwy 84 between Lake Alan Henry cut-off and Scurry County.

Judge Norman: South Plains Commissioners' Court Conference is October 29, 2025 at the Agri-Life Center in Lubbock. 2012 Bond Package on the prison will be paid off with money set aside from closing costs of the prison. The Series 2022 Bonds for the County Jail and the Series 2024 Bonds for Technology have been put into a Defeasance Account and will also be paid.
