Judge Norman called the Regular Meeting to order at 9:00 a.m.

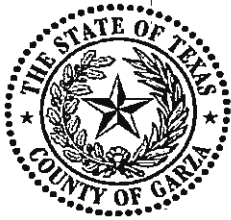
Order 1: Prayer
