



A special meeting of the Commissioners' Court of Garza County, Texas was held on Thursday, August 29, 2019 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Commissioners, Pct.1-Jeff Williams, Pct. 2-Charles Morris Pct.3-Ted Brannon and Pct. 4-Jerry Benham. Judge Lee Norman was absent.

County officials present: Jim Plummer, District and County Clerk; Ted Weems, Attorney; Terry Morgan, Sheriff; Nancy Wallace, Tax Assessor/Collector; LuAnne Terry, Treasurer;

Also present: Carol Williams, Administrative Assistant; Chris Atkinson, Community Recovery Center; and Voda B. Gradine, Post Dispatch.

Judge Pro-tem Brannon called the regular meeting to order at 9:00 a.m.

- Order 1: Reports from county offices - The following items of information were brought before the Court as a written and/or a verbal report:
1. Sheriff Morgan: the jail count is at 82, 23 are County inmates. Motion was made by Commissioner Benham and seconded by Commissioner Williams to accept the reports as presented. With a majority of the court members voting aye, the motion carried and so ordered.
- Order 2: Came on for consideration was the precinct and countywide accounts payable for August 24, 2019 through August 26, 2019. Motion was made by Commissioner Morris and seconded by Commissioner Benham that all accounts presented in the fund requirement print-out is ordered paid and presented to the Treasurer for payment. With a majority of the court members voting aye, the motion carried and so ordered. (Printout is attached.)
- Order 3: Came on for consideration was the appointment of the Early Voting team for the November 5, 2019 Constitutional Amendment Election. Motion was made by Commissioner Williams and seconded by Commissioner Morris to appoint the Early Voting team as presented: Jim Plummer, Clerk; Ginger Clemmons, Deputy Clerk; Lina Montoya, Deputy Clerk; and Shirley Taylor, Deputy Clerk. With a majority of the court members voting aye, the motion carried and so ordered. (Information is attached.)
- Order 4: Came on for consideration was to appoint the Election Day Presiding Judge and Alternate Judge for the November 5, 2019 Constitutional Amendment Election.

Motion was made by Commissioner Morris and seconded by Commissioner Benham to appoint Travis Sweet as the Presiding Judge and Barbara Davis as the Alternate Judge. With a majority of the court members voting aye, the motion carried and so ordered. (Information is attached.)

Order 5: Came on for consideration was the appointment of the Early Voting Ballot Board (EVBB) for the November 5, 2019 Constitutional Amendment Election.

A motion was made by Commissioner Benham and seconded by Commissioner Williams to appoint Kathy Beach as the EVBB Presiding Judge and Pat Cruse as the Alternate Judge. With a majority of the court members voting aye, the motion carried and so ordered. (Information attached.)

Order 6: Came on for discussion was the proposed budget. No action taken.

Order 7: Came on for consideration was the proposed tax rate. No action taken.

Order 8: Budget (workshop)  
Treasurer

Had to increase the budget for the Sheriff's office by \$16,911.50. Commissioners Williams, Morris and Brannon agreed to split the cost evenly from their precinct reserve funds.

Chris Atkinson of the Community Recovery Center explained the allocation line item, 635-401. Attorney Weems complimented the success of the Center's services and the summer pool party.

Order 9: Came on for consideration was line item corrections and budget amendment requests. None presented.

Order 10: Public comment

Voda B. Gradine expressed that the commissioners' salaries should be equal. A couple of commissioners previously denied taking an increase.

The meeting adjourned at 9:24 a.m.

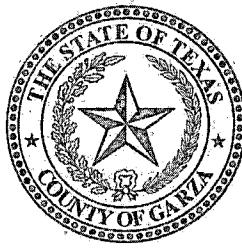
