A regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, September 9 12, 2019 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Commissioners, Pct. 1-Jeff Williams, Pct. 3-Ted Brannon and Pct. 4-Jerry Benham. Not present: Pct. 2 Commissioner Charles Morris. County officials present: Jim Plummer, District and County Clerk; Ted Weems, Attorney; Terry Morgan, Sheriff; Nancy Wallace, Tax Assessor/Collector; LuAnne Terry, Treasurer; Angela Massey, Justice of the Peace-2; and Gordon Terry, Justice of the Peace-1.

Also present: Carol Williams, Administrative Assistant; Terry Bartlett, Post Economic Development Corporation (PEDC); and Voda B. Gradine and Kendall McCullough, Post Dispatch.

Judge Norman called the regular meeting to order at 9:00 a.m.

- Order 1: Minutes from the August 26, 2019 regular meeting and the August 29, 2019 special meeting were approved as presented with a motion by Commissioner Williams and seconded by Commissioner Benham. With a majority of the court members voting aye, the motion carried and so ordered.
- Order 2: Reports from county offices The following items of information were brought before the Court as a written and/or a verbal report:
 - a. Sheriff Morgan: The billing report was submitted. August 2019 was the highest inmate revenue historically for that month. The jail count is at 93, 31 are county inmates. He sent five detention officers to be certified mental health officers. The National Sheriff's Institute chose Garza County as one of 14 Texas Counties to sit on a roundtable discussion about jail issues. Michael Copeland, the jail administrator, will represent the County.
 - b. Terry Bartlett, PEDC: The new home construction project will break ground Tuesday, 9/10/2019. Three homes will be built on Chantilly Lane. Two are sponsored by PEDC, and the other by the builder.
 - c. Treasurer
 - d. Budget Analysis and Usage
 - e. Clerk
 - f. Justice of the Peace Pct. 2
 - g. Appointed Attorneys and Fees Reports (OCA)
 - h. Registrar of Death (TEAM)
 - i. Confirmation of submission of Sheriffs' and Constables' Fees for 2020.

Motion was made by Commissioner Benham and seconded by Commissioner Brannon to accept the reports as presented. With a majority of the court members voting aye, the motion carried and so ordered. (Written reports are attached.)

- Order 3: Came on for consideration was accounts payable for August 30, 2019 through September 9, 2019.

 Motion was made by Commissioner Brannon and seconded by Commissioner Williams that all accounts presented in the fund requirement print-out is ordered paid and presented to the Treasurer for payment. With a majority of the court members voting aye, the motion carried and so ordered. (Printout is attached.)
- Order 4: Came on for consideration was the appointment of the safety committee.

 The Texas Association of County's risk management office recommends that a safety committee be appointed. Proposed members are:

 Martha Ward (law enforcement), Carol Williams (courthouse), Michael Isbell (risk management), Ted Brannon (commissioners' court), and Judge Lee Norman (elected official).

 Motion was made by Commissioner Benham and seconded by Commissioner Williams to approve the committee as proposed. With a majority of the court members voting aye, the motion carried
- Order 5: Came on for consideration was a bid from ASR Concrete Construction. The project is to redo the Giles W. Dalby Correctional Facility's parking lot entrance. The bid is for \$41,600 for the lanes entering the Dalby unit parking lot. The County will do some of the work.

 A motion was made by Commissioner Williams and seconded by Commissioner Brannon to approve the bid. With a majority of the court members voting aye, the motion carried and so ordered. (Bid is attached.)

- Order 6: Came on for consideration was a lease agreement to replace a vehicle. Sheriff Morgan explained that a patrol vehicle was recently destroyed. The sheriff found a 2019 Tahoe with 8,000 miles and is waiting on final numbers in writing.

- Order 7: Came on for consideration was the authorization of the plan for the Central Counting Station (CCS) for the November 5, 2019
 Constitutional Amendment Election.

Clerk Plummer explained that the court may authorize the plan for the CCS for the processing of Election Day ballots. Also, the CCS may also serve as the Early Voting Ballot Board as previously approved. Motion was made by Commissioner Brannon and seconded by Commissioner Benham approve the plan for the CCS. With a majority of the court members voting aye, the motion carried and so ordered. (Plan is attached.)

Order 8: Came on for announcement was the dates and times for the public budget hearings on September 16 and September 19, 2019 (both at 9:00 a.m.)

Judge Norman explained that it is on the agenda for information

purposes only. No action necessary.

The meeting resumed at 9:27 a.m.

Order 9: Budget (workshop)

The proposed tax rate is at the rollback rate.

September 23 is set to adopt the budget and set the tax rate.

Order 10: Came on for consideration was line item corrections and budget amendment requests.

One (1) budget amendment was submitted.

a. A motion was made by Commissioner Williams and seconded by Commissioner Brannon to approve the budget amendment presented for the Prec. 2 office for \$49,500.

With a majority of the court members voting aye, the motion carried and so ordered.

Commissioner Brannon thanked Carol Williams for her assistance in completing construction paperwork.

The meeting adjourned at 9:41 a.m.

The next regular meeting is Monday September 23, 2019.


