The proposed balance budget is \$9,127,435.38.

General fund revenue is expected to be \$3,085,695.52.

Appraised property values are \$528,720,172.

The meeting adjourned at 9:27 a.m.


The second of two public hearings on the budget and the tax rate is set for Thursday, September 19, 2019 at 9:00 a.m.






JEFF WILLIAMS, COMMISSIONER PCT. 1
