A regular meeting of the Commissioners' Court of Garza County, Texas was held on Thursday, October 10, 2019 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Commissioners, Pct.1-Jeff Williams, Pct. 2-Charles Morris Pct.3-Ted Brannon and Pct. 4-Jerry Benham.

County officials present: Jim Plummer, District and County Clerk; Ted Weems, Attorney; Nancy Wallace, Tax Assessor/Collector; LuAnne Terry, Treasurer; and Gordon Terry, Justice of the Peace-1.

Also present: Carol Williams, Administrative Assistant; and Kendall McCullough and Elizabeth Tanner, Post Dispatch.

Judge Norman called the regular meeting to order at 9:05 a.m.

- Order 1: Minutes from the September 16, 2019 and September 19, 2019 public hearings and the September 23, 2019 regular meeting were approved as presented with a motion by Commissioner Benham and seconded by Commissioner Brannon. With a majority of the court members voting aye, the motion carried and so ordered.
- Order 2: Came on for consideration was the rules of procedure, conduct and decorum at meetings of the county commissioners' court. Attorney Weems informed the court that the proposed rules are similar to current rules with the inclusion of law changes. The updated rules were encouraged by the Texas Association of Counties. Motion was made by Commissioner Williams and seconded by Commissioner Morris to approve the rules as presented. With a majority of the court members voting aye, the motion carried and so ordered. - Order 3: Came on for consideration was raising travel mileage costs to \$0.50. A motion was made by Commissioner Morris and seconded by Commissioner Benham to approve setting the mileage rate at \$0.50. With a majority of the court members voting aye, the motion carried and so ordered.
- Order 4: Came on for consideration was a resolution for the 2019 county court indigent defense grant program.

 Motion was made by Commissioner Williams and seconded by Commissioner Benham to approve the resolution. With a majority of the court members voting aye, the motion carried and so ordered. (Attachment)

- Order 5: Came on for consideration was Rotary International Proclamation.
 Judge Norman explained that October 24 is World Polio Day to promote the ratification of the disease.

Tax Collector Wallace announced that the tax collection rate is at 96%.


