A regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, December 9, 2019 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Commissioners, Pct. 1-Jeff Williams, Pct. 2-Charles Morris, Pct. 3-Ted Brannon and Pct. 4-Jerry Benham.

County officials present: Jim Plummer, District and County Clerk; Ted Weems, Attorney; Nancy Wallace, Tax Assessor/Collector; LuAnne Terry, Treasurer; and Terry Morgan, Sheriff.

Also present: Carol Williams, Administrative Assistant; Terry Bartlett, Post Economic Development Corporation (PEDC) & Post-Garza County Endowment; Robin Dillard and Diann Windham, Garza County Democratic and Republican Chairs; Christina Jones and Conrad Graber, Giles W. Dalby Correctional Facility; and Dakota McDonald, Post Dispatch.

Judge Norman called the regular meeting to order at 9:00 a.m.

- Order 1: Minutes from the November 25, 2019 regular meeting were approved as presented with a motion by Commissioner Benham and seconded by Commissioner Brannon. With a majority of the court members voting aye, the motion carried and so ordered.
- Order 2: Reports from county offices The following items of information were brought before the Court as a written and/or a verbal report:
 - a. Sheriff Morgan: Submitted jail revenue report and that November was the third record month in a row. The jail count is at 90, 33 are county inmates.
 - b. Tax Assessor/Collector: Continuing Education Transcript
 - c. Judge Norman: TxDoT reported that the road grant will be reinstituted for the County.

- Order 4: Came on for consideration was a Resolution for the 2020 Joint Primary Elections.

 Clerk Plummer informed the court that the county Democratic and Republican party chairs plan to enter into Joint Primary Election Services Contracts with him as the County Election Officer.


